PURPOSE:

Graduate Medical Education is to provide trainees a structured didactic experience throughout training.

POLICY:

ALL PROGRAMS

Hospital MANDATORY Meetings:

- 1. ALL trainees are expected to be in attendance, in person, or virtual in some cases, and , must be on time to meetings.
- 2. The trainee is responsible to check location and time of the meeting on that shared didactic calendar.
- 3. Trainees who are on vacation will be excused.
- 4. If a resident anticipates being late for any reason, he/she must notify their coordinator, who will then notify the GME manager.
